## 4. FIRST AID MEASURES

### 4.1 Description of Necessary First Aid Measures

<b>Ingestion:</b>	Do not induce vomiting. Immediately remove product from the mouth and wash out mouth with plenty of water. If symptoms develop, obtain medical attention.
<b>Eye:</b>	Immediately hold the eyes open and wash with fresh running water. Take care not to rinse contaminated water into non-affected eye. Ensure complete irrigation of the eye by keeping the eyelids apart and away from the eye and moving the eyelids by occasionally lifting the upper and lower lids. Remove contact lenses, if present and easy to remove. Continue rinsing. If symptoms persist, obtain medical attention.
<b>Skin:</b>	Wash skin thoroughly with plenty of water. If symptoms develop, obtain medical attention.
<b>Inhalation:</b>	Remove from source of exposure. Keep at rest until recovered. If symptoms persist, obtain medical attention.

### 4.2 Medical Attention and Special Treatment

<b>First Aid Facilities:</b>	An eye wash fountain, safety shower and general washing facility should be available immediately adjacent to the work area.
<b>Comments:</b>	Treat according to person's condition and specifics of exposure.
<b>Advice to Doctor:</b>	Treat symptomatically.

## 6. ACCIDENTAL RELEASE MEASURES

- 7.1 Precautions for Safe Handling:** Use in a well ventilated area. Avoid breathing in mists or vapour. Avoid skin and eye contact. Do not take internally. Exercise good industrial hygiene practice. Wash after handling, especially before eating, drinking, smoking or using toilet facilities.
- 7.2 Conditions for Safe Storage, Including Any Incompatibilities:** Store in a cool, dry, well ventilated area, away from heat and out of direct sunlight. Keep away from oxidising agents, strong acids and foodstuff containers.

## 8.4 Personal Protective Equipment:

### Respiratory:

### Acute
