## 4. FIRST AID MEASURES

### 4.1 Description of Necessary First Aid Measures

<b>Ingestion:</b>	Do not induce vomiting. Immediately remove product from the mouth and wash out mouth with plenty of water. If symptoms develop, obtain medical attention.
<b>Eye:</b>	Immediately hold the eyes open and wash with fresh running water. Take care not to rinse contaminated water into non-affected eye. Ensure complete irrigation of the eye by keeping the eyelids apart and away from the eye and moving the eyelids by occasionally lifting the upper and lower lids. ## 6. ACCIDENTAL RELEASE MEASURES

- 6.1 Personal Precautions, Protective Equipment and Emergency Procedures:** Avoid eye and skin contact. Determine whether to evacuate or isolate the area according to your local emergency plan. ## 8.4 Personal Protective Equipment:
